## Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease by 26% over the next five years.

## Carbon Reduction Projects

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2019 baseline:

- Lighting controls on work areas and conference rooms
- LED lighting for all new construction
- Recycling & waste management programs
- Increased Work-from-home programs (in response to COVID-19)
- Travel reduction (in response to COVID-19)

The carbon emission reduction achieved by these schemes equate to 6.08 tCO<sub>2</sub>e, a 26%ge reduction against the baseline and the measures will be in effect when performing the contract

In the future we hope to implement further measures such as:

- Participate in efforts to improve environmental protection and the sharing of appropriate knowledge, methods and working practices
- Manage the consumption of energy, water, paper and other resources used by Cloudera in day-to-day operations;
- Identify opportunities to divert, minimize, reuse and recycle our waste stream;
- Incorporate environmental considerations into procurement processes;
- Consider environmental issues when leasing or purchasing property;
- Promote staff adoption of alternative and sustainable commuter transport options;
- Strive to reduce business travel and promote alternatives wherever practicable;
- Commit to complying with applicable environmental laws and regulations;
- Educate our employees about the steps Cloudera is taking to help protect the environment and providing channels for employees to contribute to our efforts;
- Provide a space for employees to report any instances of noncompliance with applicable environmental laws and regulations and conduct appropriate follow-up.


This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.
